Staff met and developed goals. Mindy is moving to part time and will be assisting with reading intervention. Email received recommending CRS hire a music teacher and that the website needs updated board information.

4. Radon/Asbestos/Lead testing. Emails regarding concerns reviewed. They were encouraging testing. Radon testing is best done in the fall. Dixon has a contact that will like do the testing for CRS for free. If there is lead in the water, funds will be needed. Need to have timely, clear communication about testing, results and mitigation. Asbestos will need to be checked every three years. Abestos and lead testing companies have been found. Brad Kelsey will be testing for asbestos and they will create a management plan. Request for \$3,150 from the longevity fund. Jason moves to approve, Dixon seconds. **Unanimously approved.**
