- 1. Board training: Auction check in and check out.
- 2. Consent agenda: Jason moves to approve, Astrid seconds. Unanimously approved.
- 3. Audience with visitors. Susan: NCMPS Progress Report: staff working on observation practice-social emotional and executive functioning. Guides have concrete guidance on observation. Planning for Historical Halloween and it is going well. Accountability and leadership team working on staff handbook. Covering the three year process of orientation for guides. Assistants are participating in NCMPS pilot for online asynchronous training by Katie Brown. Roles of assistants: hands, hearts and eyes. This will be completed at Thanksgiving. Stars assessments have started and while the test push the children into abstraction sooner than typical in Montessori, it is a data point. Montessori tools are also used to report progress.
- 4. Fundraising –Irene: Auction will be held on Nov 2, Tickets can be purchased online, registration with self check-out.
- 5. Administrator report-see handout. Enrollment discussion. Can have up to 135 but enrollment is still down to 126. Numbers were not accurate last month so we have lost one more student and added four (from one family). Miranda stated the budget should be fine without using any contingency. There were extra funds for a band teacher and we are not yet able to hire anyone. Christine is the curriculum coach and is piloting support for lower and upper elementary. Staff meetings have a topic of an in-depth child study with different children for sharing and collaboration. Hilary is leading.








